

**Declaration of consent
for the processing and extended storage of applicant data pursuant
to section 7 GDPR**

With this declaration, I consent to the collection, storage and processing of my personal data as part of my application process (processing as defined in section 4 no. 2 GDPR).

This declaration of consent within the meaning of section 7 GDPR is voluntary and in the event that I do not provide it, it shall have no effect on my chances in the current or any future application process.

The following personal data is covered by this declaration of consent:

- As well as any personal data contained in the correspondence

The personal data listed above will be processed exclusively in connection with my application and only to the extent and as long as this is necessary. I can revoke this consent to the processing and storage of my personal data for application procedures at any time. Such a revocation shall have no effect on my chances in the application process.

In the event that I revoke my consent, my data shall be deleted immediately.

Should my application not be successful, I also expressly agree that Pates GmbH may store and process the personal data I have provided during the entire application process (as listed above) beyond this application process in order to refer me to other potential interested parties according to my profile and expectations.

I grant Pates GmbH permission to use this data to contact me at a later date whenever necessary for the reason of submitting further applications when I am considered suitable for other positions. My consent also expressly refers to documents submitted by me and the personal data contained therein, which are qualified as special types of personal data pursuant to section 9 para. 1 GDPR. These are, for example, photographs or videos that reveal an ethnic origin or severely disabled characteristics.

I hereby expressly consent to the processing of special categories of personal data within the meaning of section 9 para. 2 a) GDPR.

This consent is valid for a total period of 24 months after the application process has come to an end. In the event that my aforementioned data is of interest for Pates GmbH for further application procedures, I will be contacted after 24 months to renew my consent. In this context, my stored data shall be communicated in order to check that it is up to date. If I do not agree to the further storage of my data, Pates GmbH undertakes to delete my data once the aforementioned period has expired.

My personal data will be passed on to third parties, in particular to potential employers, only with my express consent.

In the event that I refuse further contact with Pates GmbH, I agree that my first name and surname will continue to be stored and processed even after deletion of my other personal data. This serves the purpose of identifying persons who refuse further contact, for example via social media monitoring. At Pates GmbH this process is called blocking.

My first and last name shall be used exclusively for this blocking process and may not be used in any other way. In order to make use of this blocking process, I must expressly declare to Pates GmbH that I no longer wish to be contacted.

I can also revoke my consent to the blocking process at any time in writing or via e-mail (see above) to Pates GmbH. In this case, Pates GmbH must delete my first and last name for identification purposes in the blocking process.

With my signature, I voluntarily agree to the present declaration.

I am aware that I can revoke my consent with effect for the future at any time and that I can demand information about my personal data processed by Pates GmbH at any time.
